



General Instructions

1. Registration for the Expo-cum-Conference is mandatory for applicants to the Proven and Demonstrable Technologies Component of GHTC-India.
2. Through this Component, proven and demonstrable technologies that are innovative and established to be identified and mainstreamed from around the globe for use in the Indian context. Such technologies will be screened for its suitability in the different regions of India. These technologies will be further invited to design and build 'Lighthouse Projects (LHPs)' of about 1,000 dwelling units each on about 2 hectares of land in six different locations in India. These projects will demonstrate the merits of the selected technologies and serve as live laboratories for research, testing, technology transfer, increasing mass awareness and for mainstreaming them in the country.
3. The construction of Lighthouse Projects (LHPs) will be awarded to short-listed proven technology provider after a selection process through tendering process. Any information related to GHTC-India is available on www.ghtc-india.gov.in
4. Each applicant has to submit separate applications forms for different technologies.
5. All details in the application and supporting documents must be given in SI units. Monetary information shall be provided in INR or USD.
6. One of the sub-components of GHTC-India is to enlist Indian Partners (Developers/ Construction Agencies) who are willing to provide local support to global technology providers in carrying out the construction of the Lighthouse Projects (LHPs) in different parts of India. The organizers of GHTC-India are facilitating the enlistment of such partners to create a basket of prospective Indian partners. The global technology providers are free to choose any Indian partner and it will not be binding on Global Technology Providers to collaborate with enlisted Indian partner. Also, Global Technology Providers are recommended to verify the details of local Indian partners and conduct the due diligence at its own cost and consequences.
