14th Minutes of Project Monitoring Committee (PMC) held on 10.05.2023 under the Chairmanship of Joint Secretary & Mission Director (HFA), Ministry of Housing and Urban Affairs (MoHUA) to review the progress of Light House Projects (LHPs) under Global Housing Technology Challenge - India (GHTC-India)

14th meeting of Project Monitoring Committee (PMC) was held on 10.05.2023 under the Chairmanship of Joint Secretary & Mission Director (HFA), Ministry of Housing and Urban Affairs (MoHUA) in Room No. 120-G, Nirman Bhawan with the Construction Agencies of Light House Projects (LHPs) to review the progress of LHPs and consider release of the payments for the current running bills of the LHPs submitted by the Construction Agencies. The representative(s) of four LHP Construction Agencies, respective State Government officials, members of the PMC, officials of BMTPC and PMU members of HFA Division were present in the meeting physically or in online mode. The list of participants is enclosed at **Annexure**.

- 2. The Chairman welcomed the representatives of the LHP Construction Agencies and other participants to the PMC meeting and requested Director (HFA-V) to make a presentation on the current progress of four LHPs i.e. LHP Indore, LHP Lucknow, LHP Ranchi and LHP Agartala. Highlights of the presentation were as follows:
- a. LHP Indore, Madhya Pradesh: It was submitted by vendor that most of works (except some finishing works) of Block 1,2,3 & 4 of the project have been completed. Lifts have been installed in Block 1 & 2 and lifts of towers 3 & 4 are under progress. The finishing work in Block 6,7 & 8 are in progress at the various floors. Erection of wall panels in Block 8 has not yet completed. The Construction Agency informed that all pending EPS panels have been delivered at site. Out of 1,024 DUs, erection 996 DUs is completed till date. The Agency assured that the balance panels will be installed by mid of May 2023. The representatives of Indore Municipal Corporation informed that the permanent electricity connection has been provided upto the project site as required. Five days mela was organised for publicising the scheme during which 60 beneficiaries booked flats. Considering the current progress, Agency was directed to complete the project by 15th June 2023 in all respect by increasing the manpower by double of the present strength. The Chairman informed that all remaining bills will be cleared with levy of compensation as per the Contract agreement after the approved extended timeline for all projects.
- **b. LHP Lucknow, Uttar Pradesh**: The Committee noticed that finishing work is almost completed in Block A1, C and D and installation of lift is currently under process. The Superstructure of Block A2 and B has reached upto 9th and 10th floor respectively and also finishing work is in progress simultaneously. Out of 1,040 DUs, till date 874 DUs have been erected. The Committee observed displeasure for the delay. It was observed that no SIP wall panels were erected during last one week and with the current pace of the progress, it would not be possible to complete the project by committed date of 20th May 2023. On this, the Agency representative assured to cast at least 30 DUs in the next one-week time. The Chairman directed to review the progress of the project on 19th May 2023. The Chairman informed that all remaining bills will be cleared with levy of compensation as per the Contract agreement after the approved extended timeline for all projects.

And

- e. LHP Ranchi, Jharkhand: Vendor informed that the superstructure work of Block 1, 2, 6 & 7 has been completed and finishing work is in progress. The installation work of lift is under progress in Block 1, 2, 6 & 7. Superstructure work is in progress at 5th floor in Block 5, 6th floor in Block 3 and 3rd floor in Block 4. Out of 1,008 DUs, till date 913 DUs have been erected. Infrastructure works have also started. Since the State and beneficiary share received so far is only ₹20.16 crore against ₹78.56 crore, the State should deposit the required balance share (both State + beneficiary) before 25th May 2023 so that the work is not stopped. The progress committed by the Agency in last meeting was achieved. However, the Agency was advised to put more resources and speed up the work so that the project could be completed in all respect before 30th June 2023.
- **d. LHP Agartala, Tripura:** It was observed by the Committee with concern that the progress of work of LHP Agartala is still slow. The superstructure work of Block A & F has reached upto 6th floor and in Block G, upto 2nd floor. The LGSF work of Block A & F has reached upto 3rd floor. The shear wall work of Block A, F, G for lift well has reached upto mumty and upto 6th floor in Block E. It was advised to concentrate on bringing the work of Blocks B, C & D upto plinth level before the rains so that there should not be water logging at the site and work on upper floors could continue smoothly. The Chairman emphasised that the Agency should increase manpower and other resources to complete the project by 30th September 2023.

3. Release of State and Beneficiary shares

The Committee noted the following status of release of State and Beneficiary share by respective State Government as informed by their Officials:

- i. **Jharkhand:** Out of ₹78.56 crore, only ₹20.16 crore has been received till date. Considering the current progress of project and high percentage of beneficiary share, it was advised that the State should have released at least ₹50.00 crore of the State share and Beneficiary share. In case of delay in receipt of share from beneficiaries, State may consider to release the same from its own resources so that progress of the project is not hampered. State representative informed that ₹7.00 crore collected from beneficiaries will be released by 15th May 2023.
- ii. **Madhya Pradesh:** As on date, State needs to release ₹9.33 crore of third installment.
- iii. **Uttar Pradesh:** As on date, State needs to release ₹14.74 crore of third installment.
- iv. **Tripura:** Out of ₹97.50 crore, only ₹29.17 crore has been received till date. Considering the current progress of project and high percentage of beneficiary share, the Chairman advised that the State should release the pending payment from its own resources at the earliest. Secretary (UD), Tripura informed that ₹30.00 crore is expected to be released soon.

4. Release of Payment of pending bills of the Agencies.

Director (HFA-V) apprised the PMC about the already payments made against the Running Bills submitted by the LHP Construction Agencies and TPQMA Agency. The Committee noted the details of the payments made till date for all the projects along with charges for TPQMA as under:

5. Following Running Bills for payment received from LHP Construction and TPQMA Agencies have been examined by the BMTPC for release of payment. In view of the Government of India, Ministry of Finance (Department of Revenue) vide Notification No. 03/2022-Central Tax (Rate) dated 13th July, 2022 and extension of time granted by the Ministry vide letter No. N-11011/17/2022-HFA-V-UD/FTS-9129936 dated 8th May 2023, the Committee also considered and approved reimbursement of additional GST @6% (increase from 12% to 18%) for pending bills after 18.07.2022.
